## **1. General comments**

This mission report was prepared within the EU Twinning Project “Support to the State Statistical Committee and the State Tax Service under the Ministry of Economy to strengthen collection, harmonization, analysis, publishing and dissemination of business statistics”. It was the third mission to be devoted to ‘A business case for compliance of the statistical units in the SRSU developed’ within Component 1, Result 2 within Activity 2.1 of the project.

The purposes of the mission were:

- Capacity building in Statistical Enterprise; profiling and consolidating

The consultant would like to express his/her thanks to all officials and individuals met for the kind support and valuable information which he/she received during the stay in Azerbaijan (or Remote Sessions and which highly facilitated the work of the consultant.

## **2. Status at the beginning of the mission**

Activity 2.1.C was carried out on four Remote Sessions (RS - WebEx meetings). Last RS presented the observations made during the previous sessions and translated into proposals for improvement of the process, whereas the RS's before focused on analysing the situation in STS and SSC and presenting best practices out of MS.

- The mission was a direct continuation of activities 2.1.A and 2.1.B.
- On previous missions BC expressed their wish to focus the content of the missions on enterprise group register issues, instead of statistical unit enterprise issues. As the profiling of the statistical unit enterprise requires a well-developed enterprise group register, focusing on EGR was agreed by all parties.
- At present there are no large-scale data source for the compilation of the AZ enterprise groups. An analysis of the administrative data with subordination showed that this data only had links for governmental units and therefore in its current form cannot be used as a point of departure for the creation of EGs
- Negotiations with the STS of the acquisition of the ownership data concerning market-oriented businesses were started after the previous mission (negotiations ongoing).

## **3. Status of mission results**

- In project formulation phase this mission was devoted for statistical unit enterprise but BC expressed their wish to focus the content on enterprise group register.
- It was found that the EG information on AZ companies web pages is very limited compared to EU public listed companies. This data can still be used as a demo data on EG register set-up.
- Direct data collection of the very largest AZ EGs was considered, and an example of direct data collection form was presented in the meetings
- Example of the EG data model with tables, relations, variables and explanations was presented on Excel file. BC will study further this data model. BC will load data of two AZ EGs in the Excel sheets according to this data model.
- A list of top 50 AZ EGs will be prepared by BC. This list can be used as a starting point for pilot data collection for EG purposes.

#### **4. Sustainability of the achievements**

The BC has started applying presented methods for trial runs on a few very large enterprise groups. The EG information concerning these EGs is acquired from companies' web pages. Getting access to relevant administrative data or other sources containing ownership links (e.g. financial reports) is, however crucial for the sustainability of the work.

#### **5. Recommendations for the future (short and long term)**

- Efforts for getting the ownership data from STS to SSC should be continued
- Possibilities for direct data collection of the very largest AZ EGs should be further studied
- Outline way forward to implement changes in the BR structure and needed software changes for EGR
- BC should only proceed with implementation of the statistical unit enterprise after the establishment of the enterprise group register

#### **6. Identification of needs for additional support**

BC should be able to proceed the work with enterprise groups. The need for additional activities within this project, component 1 and result 2 will be assessed after the summer.
